The **Southeast Finland Border Guard District** processes border zone permit applications for Imatra, Lappeenranta, Miehikkälä, Parikkala (excl. the Lake Pyhäjärvi water area in the municipality of Parikkala), Rautjärvi and Ruokolahti and the land areas of Virolahti.

The **Gulf of Finland Coast Guard District** processes border zone permit applications for Hamina, Kotka and the sea areas of Virolahti.
